**Child education and care**, in case the child is under the age of 14 years old at the beginning of the particular semester (§ 6 paragraph 1 No. 1 LL.M.-Statute).

Verifications:

1. Birth certificate of the child (only for **first** applications) and
2. Actual confirmation of registration which brings evidence that you live in community with your child. You get this certificate at your local registration office.

**Disability** according to § 2 Ninth Book of Social Code (SGB IX) or **comparable chronic disease** is given which **considerably impedes studies** (§ 6 paragraph 1 No. 2 LL.M.-Statute).

Verifications:

1. Degree of disability **50% and more:**  
As a rule the submission of a valid identification of severe disablement is sufficient.
2. Degree of disability **under 50%:**  
Submission of the notification of the pension office according to § 69 SGB IX.
3. Chronic disease, which is comparable with a severe disability:  
Submission of a short medical report of a specialist which explains intelligibly the character and the considerable impediment of the chronic disease on the studies.

Verifications:

Proof of admittance in one of the nationwide operative scholarship systems which are supported by the Federal Ministry of Education and Research. This verification should include the exact duration of the scholarship (§ 7 paragraph 5 LL.M.-Statute).

Applications for exemption must be filed by before beginning of the lecture period (§ 6 paragraph 5 sentence 2 LL.M.-Statute). I am aware of the fact that all of my data are the basis for a possible exemption from paying tuition fees and that I have to give immediate notice about any subsequent changes.
